

**SLINGSBY, SOUTH HOLME AND FRYTON PARISH COUNCIL MEETING**  
**held in the Village Hall on Monday November 18<sup>th</sup> 2013 at 7pm.**

**MINUTES**

**Present:** Councillors C Wilson (Chairman), A Shepherd, M Singleton, F Farnell and P Snowball. Also present were D Farley (Clerk), County Councillor C Wood, District Councillor R Wainright and two members of the public.

Cllr C Wood gave a report on the work being done by NYCC. She assured everyone that work would begin on The Lawns to stop the road flooding in the future. The Highways authority has no objection to the trees and bushes being cut back to give better sight of the road signs at the cross roads. The slow signs at South Holme had been done but it was unlikely that anything would be done at Ness bridge.

Cllr Wainright said that Ryedale hoped to keep the Council Tax rise to less than 2%. A charge of £27 per annum will be made for the brown bins. There is no cap on Parish Council precepts.
