## 7. Village Items

#### Street Lights

No lights have been reported for repair.

The Parish Council received a letter from a resident requesting that the streetlight at the bottom of The Lawns be reinstated back to its original position. Following the survey in 2014, it was agreed that a further survey will be carried in November 2019 if required. Cllr Farnell abstained from voting on this issue.

#### **Highways Issues**

The Clerk to contact NYCC regarding the white lines to be re-painted in the village, with particular focus on junctions.

- ACTION: Clerk to contact Cavendish Homes regarding the completion of the white lines.
- ACTION: Clerk to report pot hole repairs at the Bottom of The Balk around the manhole around the corner, Railway Street before and after the bridge and outside Brickyard Farm, left hand side.

## Footpath Review

Maintenance work is required on the path from Cavendish Court to the Main Road and High Street.

ACTION: Clerk and Chairman to arrange for two quotes for Siding out from Cliffords to the Main Road on both sides of the road.

## Tree Maintenance Works

Castle Howard Tree Officer has surveyed the trees on The Green, he has recommended some work which could be carried out early in the new year.

There is also some urgent tree work required in the cemetery. The Parish Council have received one quote,

ACTION: Clerk to arrange for an additional quote.

## **Section 106 Application**

Ryedale District Council have consulted the Parish Council on the application for Section 106 funding received by Slingsby Sportsfield Association for £23,844.

Members approved this application unanimously.

## **Public Rights of Way**

The Clerk notified the NYCC Rights of Way Officer that the path from Green Dyke Lane to Railway Line was blocked, they confirmed that this will be cleared imminently

## 8. Chairman's Report

The Chairman gave a verbal update. There is some work to be carried out on the sewerage works in February/March time. A site meeting is due to be carried out in January.

## Mobile Library

It has been suggested that the times of the library be changed from 2pm-4pm to 1.30-3.30pm to enable school children to have time to visit the library. Members of the Parish Council would support the change of time.
